FIDAM REGULATIONS

These rules are there to try to protect all affiliates, trainers, competitors, referees and promoters. With which any agreement can be reached that the parties involved consider appropriate, as long as FIDAM is up to date and accepts them so as not to harm third parties.

1º All clubs, associations or federations will be able to benefit from being registered in as many disciplines as the FIDAM welcomes with a single annual affiliation of club, association or federation.

2nd Active Teachers, Instructors, Monitors, Assistant Monitors, Black Belts and Referees have the obligation to obtain the annual FIDAM PROFESSIONAL TRAINING LICENSE.

If you do not have the VOCATIONAL TRAINING LICENSE in force, our database programs will automatically deregister you as a graduate and the title will not have any validity.



3º Athletes may be amateurs or professionals, and may obtain a FEDERATIONAL license approved by FIDAM at an international level.

Each FIDAM Delegation in each country must obtain the appropriate Medical Insurance according to its current legislation. If applicable, FIDAM, depending on the country of origin, may issue international insurance.

4º Any competition referring to Martial Arts in general and Contact Sports must be composed of at least 10 combats, which may be either male or female.

5º The FIDAM Sports Regulations are governed by international standards.

6º FIDAM qualifications at an international level will be awarded in the sports field in the following way:

Black Belts in the corresponding Martial Art disciplines (Karate, Taekwon-do, Kung Fu, Tai Chi, Jiu Jitsu etc...). In Contact Sports (Full-Contact, Kick Boxing, K1 and MMA) in the same way, except in the Muay Thai discipline that they will be Khans.

7º As a FIDAM teaching qualification, the titles of:

- Monitor
- Coach
- Assistant Coach
- Regional Coach
- National Coach
- Regional Referee
- National Referee
- International Referee
- World Referee.

8th FIDAM will organize exam calls and training courses during the year, having to indicate the place, dates and name of the Teacher or Instructors who will teach the training courses (TECHNICIANS, MONITOR, REGIONAL - NATIONAL COACH and REFEREES, in the case of exams, BLACK BELTS) the people who will be summoned to the NATIONAL COURT OF DEGREES.

9th FIDAM regarding Black Belt exams, 1st DAN and MONITOR BLACK BELTS may examine up to the BLUE belt.

To examine a BROWN belt, a 2ND DAN BLACK BELT and REGIONAL TRAINER qualification will be required.

For the higher degrees of BLACK BELTS, MONITORS, COACHES etc... it will be necessary to go through a NATIONAL COURT OF DEGREES.

10º It will be the obligation of the Referees Committee to carry out an annual course and to deliver the new qualifications, this department has to try to be as independent as possible.

11º At the National and International level, the following federative licenses will be issued:

Federal Children's License

Junior Class E federal license

Class D Amateur Federation License

Class C Amateur Federation License

Neo Professional Class B federal license

Professional federation license (special teaching) not valid to compete.

Class A Professional Federation License

Black Belt holders, Coaches, Monitors, Regional Trainers, National Trainers and professional Referees who are active refereeing in FIDAM competitions must obtain the federative Vocational Training license. Requirements to obtain an Annual Federative License:

- Duly completed application scanned
- Photocopy of the ID of the interested party scanned
- 1 scanned passport size photo
- Scanned Medical Certificate (For competitors)
- Photocopy of scanned proof of payment



12º All athletes affiliated with FIDAM have the right to hold grade exams and compete in all championships for which they are qualified.

Every athlete who participates in official competitions must present the Medical Review Certificate to the FIDAM secretary.

This Medical Certificate will be valid for one year from the date of issue.

13º All athletes to attend official FIDAM competitions must obtain a SPORTS PASSPORT.



This SPORTS PASSPORT will be valid in the current year, which will reflect all types of sporting events that said competitor attends (training courses and official championships). These official courses and championships will be approved by FIDAM.

14. In the corner of the TATAMI, the competitor must be accompanied by a coach duly certified by FIDAM, and will wear a tracksuit or clothing from their gym.

15th FIDAM must appoint a delegate who will be responsible for the proper development of the competition and for sending the results to the Competition Committee. The Competition Delegate will have the obligation to fill out sheets with the results and send them to the Central so that the fights are recognized and approved.

In the event that the delegates fail to comply with these rules, they will be dismissed.

16º FIDAM recognizes the right of its members to participate in other championships of other federations or associations, as long as FIDAM Central is notified beforehand.

These results must be reflected in the FIDAM SPORTS PASSPORT.

Affiliates or clubs that fail to comply with this rule will be sanctioned by the Disciplinary Committee.

17º All FIDAM athletes who go abroad to compete must notify the Central Office in writing 10 days in advance so that it can process travel permits. In the document they must specify the name of the athletes who have to travel, the place of celebration, the date and time.

If these athletes access on their own without informing FIDAM Central, they will be sanctioned by the Disciplinary Committee.

18th MEDICAL CERTIFICATION: A competitor will not be allowed to participate in a fight if he does not have the annual federation license in force with its corresponding Sports Medical Insurance and Sports Passport, in addition he must possess the Medical Certificate, issued by a qualified Doctor in Sports Medicine. that certifies whether the competitor is fit to fight.

This Medical Certificate will be valid for one year from the date of issue.

MEDICAL RECOGNITION: During the period of time dedicated to Weighing, and before being weighed, a competitor must be considered FIT (after having been examined by the Official Medical Officer designated by the Competition Committee).

19º Throughout the world, approvals in competitions are as follows:

OPEN REGIONAL CHAMPIONSHIP

OPEN NATIONAL CHAMPIONSHIP

OPEN IBERIAN CHAMPIONSHIP

OPEN MEDITERRANEAN CHAMPIONSHIP

OPEN PAN AMERICAN CHAMPIONSHIP

OPEN CONTINENTAL CHAMPIONSHIP

OPEN INTERCONTINENTAL CHAMPIONSHIP

OPEN WORLD CHAMPIONSHIP

The prices of the approvals are not negotiable although FIDAM reserves the right to reach any agreement with the promoters. In the competitions, FIDAM, the promoters will be responsible for paying the stay and the arbitration fee stipulated by FIDAM.

20º The uniform of the FIDAM referees will be a COLORED POLO TYPE shirt with the FIDAM - GBF logo, black pants, black socks and black sneakers.



21º FIDAM will authorize the participation of competitors from other federations or associations in their championships, for this they must obtain the 1-Day federative license. 1-day license (includes sports medical insurance)

22º FIDAM will periodically organize National, Children, Cadet and Senior Leagues, qualifying for the National, International and World Championships. In each country, a National team will be prepared to compete every 2 years in the championships that will be organized at the continental and World level. With this measure FIDAM aims to achieve greater technical quality than its competitors.

23º The competition regulation in each FIDAM discipline is the only one valid to sanction FIDAM fights and titles. In case of disagreement, the Coaches and competitors will have to submit to what the College of Referees dictates.

24º The Promoters must obtain the license of:

AMATEUR PROMOTER - Exclusively Amateur Events

These licenses include Civil Liability Insurance for all events and training courses that the Promoter carries out throughout the current year.

The Promoters have the obligation to cover the expenses of a supervisor in each evening, who will take care of sending the chronicle, photos, videos to send to FIDAM Central once the sporting event or training course has taken place, for its subsequent publication on our website www. .fidamworld.com

If two promoters agree on the date and place, it will be submitted to FIDAM for study.

25th FIDAM will recognize all regional, national and international federations or associations by appointing a DELEGATE in each country and being in charge of ranking both Regional and National competitors for their country. The competitions will be governed by the FIDAM Regulations in their different disciplines.

26th FIDAM grants itself the power to dismiss any delegate who acts in bad faith or against the interests of FIDAM at the regional, national or international level.

27th FIDAM in its desire for growth will help all affiliated clubs and athletes to the extent possible.

28º The competition doctor will have to be recognized by FIDAM and show that he has the knowledge that the combat disciplines need.

29º Create a network of doctors, specialists in Contact Sports, throughout the National territory in each country.

30º If another federation acts in bad faith preventing the growth of FIDAM or harming any of its athletes, it will be automatically sanctioned by FIDAM, preventing the participation of its athletes in championships of that federation, association or organization.

31º International Delegations must pay the deductibles annually. Payments must be made from January 1 to 10.
